Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, to conduct and communicate those hazards and then to further take steps to either eliminate or control each hazard.			
If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.			
Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.			
The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

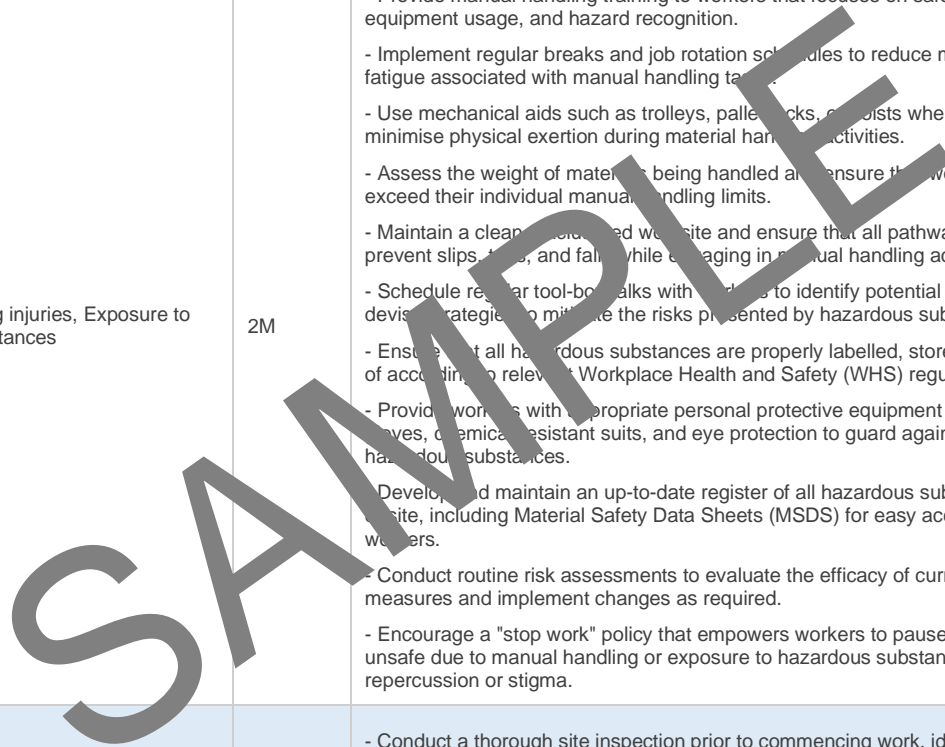

Note: A SWMS must be reviewed regularly to make sure it remains effective. A SWMS must be reviewed (and revised if necessary) if relevant control measures are revised. The review process should be carried out in consultation with workers (including contractors and subcontractors) who may be affected by the operation of the SWMS and their health and safety representatives who represented that work group at the workplace.

When a SWMS has been revised, the person conducting a business or undertaking must ensure all:

1. persons involved in the work are advised that a revision has been made and how they can access the revised SWMS;
2. persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS; and,
3. workers that will be involved in the work are provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

Preparation	Manual handling injuries, Exposure to hazardous substances	2M	<ul style="list-style-type: none"> - Provide manual handling training to workers that focuses on safe lifting techniques, equipment usage, and hazard recognition. - Implement regular breaks and job rotation schedules to reduce muscle strain and fatigue associated with manual handling tasks. - Use mechanical aids such as trolleys, pallet jacks, or hoists whenever possible to minimise physical exertion during material handling activities. - Assess the weight of materials being handled and ensure that workers do not exceed their individual manual handling limits. - Maintain a clean and organised worksite and ensure that all pathways are clear to prevent slips, trips, and falls while engaging in manual handling activities. - Schedule regular tool-box talks with workers to identify potential hazards and devise strategies to mitigate the risks presented by hazardous substances. - Ensure that all hazardous substances are properly labelled, stored, and disposed of according to relevant Workplace Health and Safety (WHS) regulations. - Provide workers with appropriate personal protective equipment (PPE), such as gloves, chemical resistant suits, and eye protection to guard against exposure to hazardous substances. - Develop and maintain an up-to-date register of all hazardous substances used on site, including Material Safety Data Sheets (MSDS) for easy accessibility by workers. - Conduct routine risk assessments to evaluate the efficacy of current control measures and implement changes as required. - Encourage a "stop work" policy that empowers workers to pause tasks if they feel unsafe due to manual handling or exposure to hazardous substances, without fear of repercussion or stigma. 	1L	
2. Site Assessment	Slips, trips and falls, Traffic hazards	3H	<ul style="list-style-type: none"> - Conduct a thorough site inspection prior to commencing work, identifying any potential slip, trip and fall hazards, and mark out safe access paths. - Utilise appropriate signage to provide clear directions for traffic, pedestrians, and workers, reducing the risk of vehicular accidents and pedestrian involvement on site. - Keep the worksite clean and tidy, regularly clearing excess debris and drilling material to prevent unnecessary obstructions and reduce the likelihood of slips, trips, and falls. - Implement an effective hazard reporting process, allowing team members to quickly identify and relay information about potential site hazards, leading to proactive hazard management and prevention. - Ensure all personnel have been trained in proper directional drilling procedures and workplace safety guidelines, promoting adherence to safety protocols at all times. 	2M

Bore Path Planning	Struck by moving equipment, Falls from height	3H	<ul style="list-style-type: none"> - Conduct a thorough risk assessment before initiating the bore path planning process, identifying potential hazards and appropriate controls. - Ensure all workers involved in the planning process are adequately trained and competent in their designated roles, including the use of relevant equipment and software. - Implement exclusion zones around the work area to prevent unauthorised access or interaction with moving equipment during the bore path planning stage. - Establish clear communication protocols amongst team members, ensuring everyone is aware of the planned activities and any changes to the plan. - Utilise appropriate personal protective equipment (PPE), such as hard hats, high visibility clothing, and safety boots, to minimise the risk of injury from struck-by incidents and falls. - Inspect all equipment, including ladders and elevated platforms, prior to use to ensure they are in good working condition and compliant with Australian standards. - Use guardrails, fall arrest systems, or other effective fall protection measures when working at heights during the bore path planning process. - Avoid overloading scaffolds or elevated platforms, and do not exceed the manufacturer's recommended weight limits for equipment. - Carry out regular inspections and maintenance of equipment and tools to minimise malfunctions and potential accidents during the bore path planning stage. - Implement a traffic management plan in areas where vehicles and heavy machinery will be operating to reduce the risk of collisions and struck-by incidents. 	1L

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are needed. The review process should be carried out in consultation with workers (including contractors and subcontractors) who may be affected by the operation of the SWMS and their health and safety representatives who represented that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
