Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.			
If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.			
Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.			
The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

**Notes on Hierarchy of Controls:** Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

The review process should be carried out in consultation with workers (including contractors and subcontractors) who may be affected by the operation of the SWMS and their health and safety representatives who represented that work group at the workplace.

When a SWMS has been revised, the person conducting a business or undertaking must ensure all:

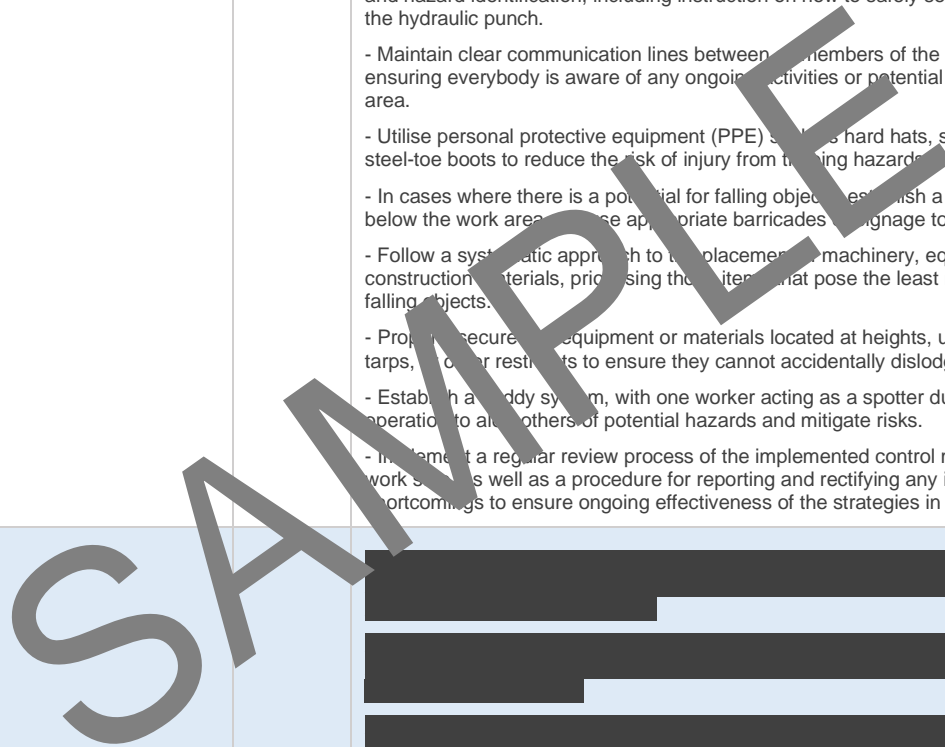
1. persons involved in the work are advised that a revision has been made and how they can access the revised SWMS;
2. persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS; and,
3. workers that will be involved in the work are provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

Preparation	Incorrect equipment selection, Poor site conditions	2M	<ul style="list-style-type: none"> <li>- Undertake a thorough risk assessment before selecting the appropriate hydraulic punch equipment for the specific task and site conditions, keeping in mind factors like material strength, size, and working area.</li> <li>- Ensure workers are trained and competent in using hydraulic punch equipment including proper operation, maintenance, and safety procedures.</li> <li>- Always read and follow equipment manufacturer guidelines for safety, operation, and maintenance when using a hydraulic punch machine.</li> <li>- Visit and assess the worksite prior to commencing work, ensuring that all potential risks, hazards, and other relevant factors like ground stability, weather, and space constraints are documented and addressed.</li> <li>- Establish clear communication channels between team members on-site, ensuring that everyone remains informed of planned activities, upcoming changes, or identified hazards.</li> <li>- Develop a site-specific emergency response plan that covers all possible scenarios related to the use of hydraulic punch equipment, with clearly defined roles and responsibilities for each team member during an incident.</li> <li>- Provide suitable Personal Protective Equipment (PPE) for workers, such as safety gloves, goggles, hard hats, and high-visibility clothing, and ensure their proper usage throughout the work process.</li> <li>- Designate specific areas for equipment storage and movement to avoid congestion and tripping hazards at the worksite.</li> <li>- Regularly evaluate and maintain hydraulic punch equipment to ensure optimal performance, minimise the risk of equipment failure, and identify any wear and tear that could cause safety concerns.</li> <li>- Set up temporary barriers and signage around the work area as necessary, alerting other workers, pedestrians, or vehicles of potential hazards or restricted access.</li> <li>- Implement regular safety meetings and toolbox talks, encouraging open dialogue and feedback from team members about ongoing tasks, safety concerns, or operational improvements related to hydraulic punch equipment and worksite operations.</li> </ul>	1L

			<ul style="list-style-type: none"> <li>- Use qualified personnel with appropriate knowledge and experience to inspect and assess the hydraulic punch equipment's condition.</li> <li>- Consult manufacturer guidelines and recommendations, ensuring that inspections adhere to these standards and maintenance protocols.</li> <li>- Maintain proper documentation of all inspections performed, including dates, findings, and any corrective actions taken. Keep these records on file to reference requirements during future inspections.</li> <li>- Remove from operation any equipment that does not pass inspection or is considered faulty, until repairs have been successfully completed by a qualified technician.</li> <li>- Regularly check hydraulic hoses and connections for any signs of damage or leaks that could compromise the machine's performance or safety.</li> <li>- Ensure that all safety guards and mechanisms are in place, functioning correctly, and free from obstructions before beginning the operation of hydraulic punches.</li> <li>- Keep a log of any malfunctions, accidents, or near-misses related to hydraulic punch equipment, investigating their underlying causes to prevent recurrence.</li> <li>- Review tooling and consumables being used with the hydraulic punch, replacing those as needed to maintain optimum performance and safety.</li> <li>- Perform any preventative maintenance tasks recommended by the manufacturer, which could include lubricating parts, checking for proper alignment, and tightening bolts.</li> <li>- Utilise appropriate personal protective equipment (PPE) during inspections, such as gloves, safety glasses, and footwear, to minimise the risk of injury while handling the hydraulic punch equipment.</li> </ul>

			<ul style="list-style-type: none"> <li>- Establish a comprehensive training programme for workers on safe work practices and hazard identification, including instruction on how to safely set up and operate the hydraulic punch.</li> <li>- Maintain clear communication lines between all members of the work team, ensuring everybody is aware of any ongoing activities or potential hazards in the area.</li> <li>- Utilise personal protective equipment (PPE) such as hard hats, safety glasses, and steel-toe boots to reduce the risk of injury from tripping hazards and falling objects.</li> <li>- In cases where there is a potential for falling objects, establish a "no-go zone" below the work area and use appropriate barricades and signage to prevent entry.</li> <li>- Follow a systematic approach to the placement of machinery, equipment, and construction materials, prioritising the items that pose the least risk of becoming falling objects.</li> <li>- Properly secure all equipment or materials located at heights, using tie-downs, tarps, or other restraints to ensure they cannot accidentally dislodge or fall.</li> <li>- Establish a buddy system, with one worker acting as a spotter during setup and operation to alert others of potential hazards and mitigate risks.</li> <li>- Implement a regular review process of the implemented control measures for this work step as well as a procedure for reporting and rectifying any identified shortcomings to ensure ongoing effectiveness of the strategies in place.</li> </ul>

**SAFE WORK METHOD STATEMENT MONITORING AND REVIEW**

**The SWMS must be reviewed regularly** to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are needed. The review process should be carried out in consultation with workers (including contractors and subcontractors) who may be affected by the operation of the SWMS and their health and safety representatives who represented that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

**The SWMS must be monitored regularly** for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
