Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, conditions and then to communicate those hazards and then to further take steps to either eliminate or control each hazard.			
If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.			
Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.			
The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

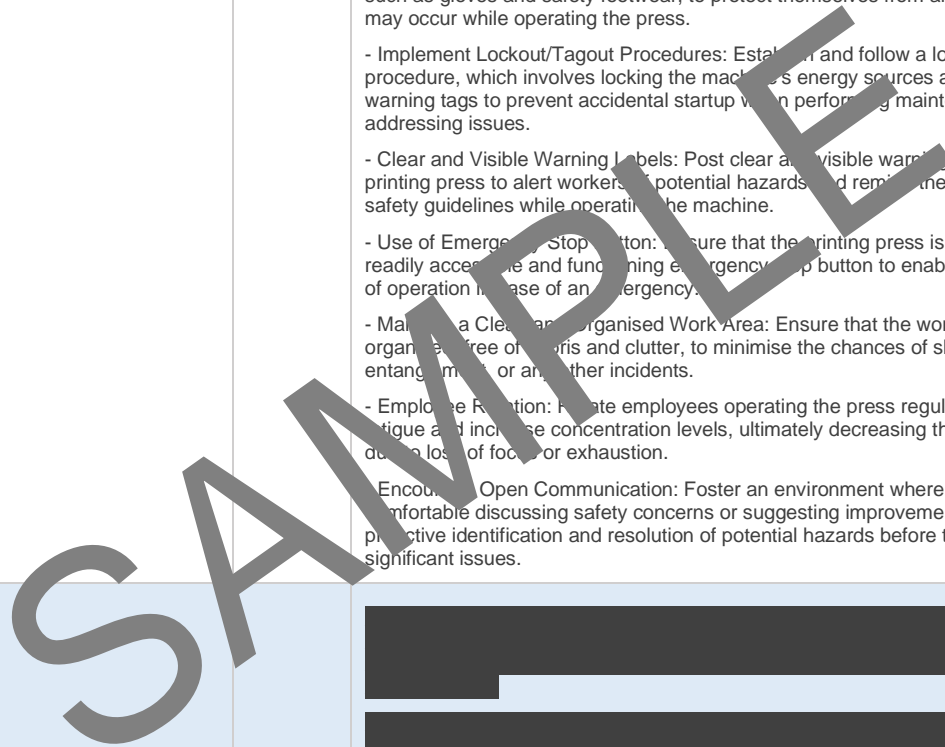

			<ul style="list-style-type: none"> - Ergonomic workstations: Design and set up workstations ergonomically to reduce the risk of injury from repetitive movements or awkward postures during material loading. - Maintain machinery: Regularly inspect and maintain the printing press and any associated equipment to ensure it is functioning correctly and safely, effectively minimising the risk of pinch points or other machine-related injuries. - Clear signage: Display clear warning signs around the area where raw materials are being loaded, alerting workers to the potential hazards. - Communication and teamwork: Encourage open communication among team members when loading materials, ensuring proper coordination and promoting safe practices. - Limit load weights: Implement strict guidelines for maximum load weights, preventing workers from carrying objects that are too heavy and posing risks to their health and safety. - Emergency stop buttons: Equip machines with accessible emergency stop buttons to halt operation immediately if there is a risk of injury or accident. - Use of barriers: Install physical barriers or guards around the printing press machinery to prevent hands or fingers from entering pinch point areas. - Safe storage of materials: Store raw materials properly, keeping them in designated areas away from obstructions or potential hazards to workers. - Standard operating procedures: Establish comprehensive standard operating procedures (SOPs) for loading raw materials, ensuring that all steps are followed correctly and consistently, minimising the risk of accidents. - Toolbox talks & refresher courses: Regularly conduct toolbox talks, discussing the hazards associated with loading raw materials and how to mitigate them. 			<ul style="list-style-type: none"> - Personal Protective Equipment (PPE): Ensure that workers wear appropriate PPE, such as gloves and safety footwear, to protect themselves from any hazards that may occur while operating the press. - Implement Lockout/Tagout Procedures: Establish and follow a lockout/tagout procedure, which involves locking the machine's energy sources and attaching warning tags to prevent accidental startup when performing maintenance or addressing issues. - Clear and Visible Warning Labels: Post clear and visible warning labels on the printing press to alert workers of potential hazards and remind them to adhere to safety guidelines while operating the machine. - Use of Emergency Stop Button: Ensure that the printing press is equipped with a readily accessible and functioning emergency stop button to enable instant stoppage of operation in case of an emergency. - Maintain a Clean and Organised Work Area: Ensure that the work area is well-organised, free of debris and clutter, to minimise the chances of slips, trips, entanglements, or any other incidents. - Employee Rotation: Rotate employees operating the press regularly to help reduce fatigue and increase concentration levels, ultimately decreasing the risk of accidents due to loss of focus or exhaustion. - Encourage Open Communication: Foster an environment where workers feel comfortable discussing safety concerns or suggesting improvements, allowing for proactive identification and resolution of potential hazards before they become significant issues.

The review process should be carried out in consultation with workers (including contractors and subcontractors) who may be affected by the operation of the SWMS and their health and safety representatives who represented that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
