Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, to conduct and communicate those hazards and then to further take steps to either eliminate or control each hazard.			
If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.			
Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.			
The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

**Notes on Hierarchy of Controls:** Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

**Note:** A SWMS must be reviewed regularly to make sure it remains effective. A SWMS must be reviewed (and revised if necessary) if relevant control measures are revised. The review process should be carried out in consultation with workers (including contractors and subcontractors) who may be affected by the operation of the SWMS and their health and safety representatives who represented that work group at the workplace.

When a SWMS has been revised, the person conducting a business or undertaking must ensure all:

1. persons involved in the work are advised that a revision has been made and how they can access the revised SWMS;
2. persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS; and,
3. workers that will be involved in the work are provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

Preparation	Trip hazards, Electrical hazards	2M	<ul style="list-style-type: none"> <li>- Regular inspection and maintenance of the work area to identify and rectify any potential trip hazards such as uneven surfaces, cords and cables, or debris.</li> <li>- Use proper signage and barriers around the Line Borer machine and in designated walkways to minimise risk from trip hazards as workers move throughout the area.</li> <li>- Ensure that all power cords and extension leads used with electrical equipment are in good condition, without damage, frayed wiring or exposed conductors.</li> <li>- Follow appropriate lockout/tagout procedures when operating, servicing or maintaining electrical equipment in order to prevent accidental energization.</li> <li>- Use Ground Fault Circuit Interrupter (GFCI) outlets or portable GFCI devices to protect against ground faults and reduce the likelihood of electrical shocks.</li> <li>- Provide adequate lighting in the work area to ensure workers can easily identify and avoid potential risks related to trip and electrical hazards.</li> <li>- Implement regular training sessions for employees to reinforce awareness of workplace health and safety policies, including how to identify and minimise trip and electrical hazards in the day-to-day operations.</li> <li>- Store tools, materials, and equipment properly when they are not in use to keep the work area organised and free from clutter that may contribute to trip hazards.</li> <li>- Encourage workers to wear proper footwear that provides support, slip resistance, and electric shock protection as well as other required personal protective equipment (PPE) where necessary.</li> <li>- Ensure that a qualified electrician conducts inspections of all electrical installations at regular intervals to identify any potential electrical issues before they escalate into serious hazards.</li> </ul>	1L	
2. Line Borer Set-Up	Manual handling, Falling equipment	3H	<ul style="list-style-type: none"> <li>- Implement proper manual handling training for all workers involved in the Line Borer Set-Up, emphasising correct lifting techniques and body mechanics to reduce the risk of injuries.</li> <li>- Schedule regular breaks for workers during the set-up process to prevent fatigue and ensure they have adequate time for rest and recovery.</li> <li>- Provide appropriate personal protective equipment (PPE), such as gloves, safety footwear, and high-visibility vests to all employees involved in the Line Borer Set-Up.</li> <li>- Utilise mechanical aids or equipment such as trolleys, hoists, or forklifts for handling heavy or awkward items when setting up the Line Borer, reducing the strain on workers.</li> <li>- Ensure that all equipment used during the Line Borer Set-Up, including lifting devices and rigging, are regularly inspected and maintained according to the manufacturer's guidelines.</li> <li>- Identify potential pinch points, trip hazards, or other obstacles in the working area and eliminate or minimise them before beginning the set-up process.</li> </ul>	2M

			<ul style="list-style-type: none"> <li>- Establish a clear communication system among workers engaged in the Line Borer Set-Up, including using hand signals, two-way radios, or designated spotters to reduce the risk of accidents or mishaps.</li> <li>- Implement a buddy system, whereby workers assist and watch out for each other during the set-up process, promoting teamwork and enhancing safety awareness.</li> <li>- Ensure that any equipment or materials that need to be lifted or manipulated during the set-up process are securely fastened and properly balanced to minimise the risk of falling equipment.</li> <li>- Develop and implement an emergency response plan specific to situations involving falling equipment or injuries related to manual handling during the Line Borer Set-Up, including first aid procedures and evacuation protocols.</li> <li>- Conduct regular safety meetings and toolbox talks to refresh workers' knowledge on proper techniques, hazard identification, and control measures linked to the Line Borer Set-Up process.</li> <li>- Regularly review and update the SWMS to reflect new information or changes in the work environment, ensuring that all control measures are up-to-date and effective in minimising hazards during the Line Borer Set-Up.</li> </ul>

Measuring Workpiece	Sharp edges, Eye strain	3H	<ul style="list-style-type: none"> <li>- Personal Protective Equipment (PPE): Ensure that all workers wear appropriate PPE, including safety glasses or goggles and gloves, to protect their eyes and hands from sharp edges and debris.</li> <li>- Proper Training and Supervision: Offer training on how to handle tools and equipment involved in the measuring process, as well as educate them on potential hazards and risks associated with this task. **SAFE WORK METHOD STATEMENT MONITORING AND REVIEW**

**The SWMS must be reviewed regularly** to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are needed. The review process should be carried out in consultation with workers (including contractors and subcontractors) who may be affected by the operation of the SWMS and their health and safety representatives who represented that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

**The SWMS must be monitored regularly** for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
