Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, to conduct and communicate those hazards and then to further take steps to either eliminate or control each hazard.			
If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.			
Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.			
The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

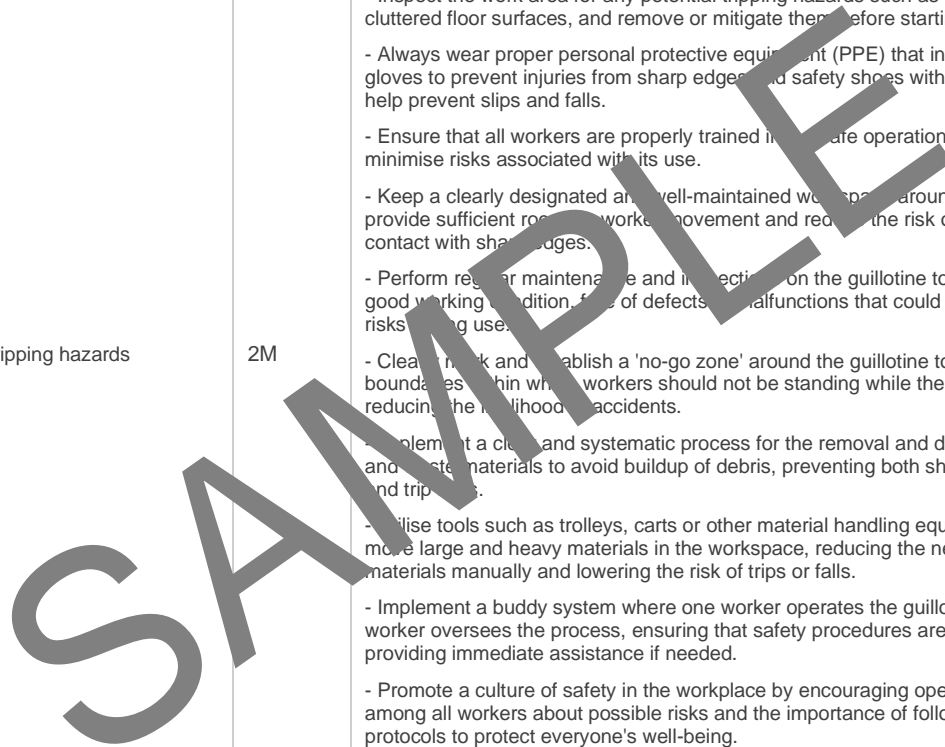

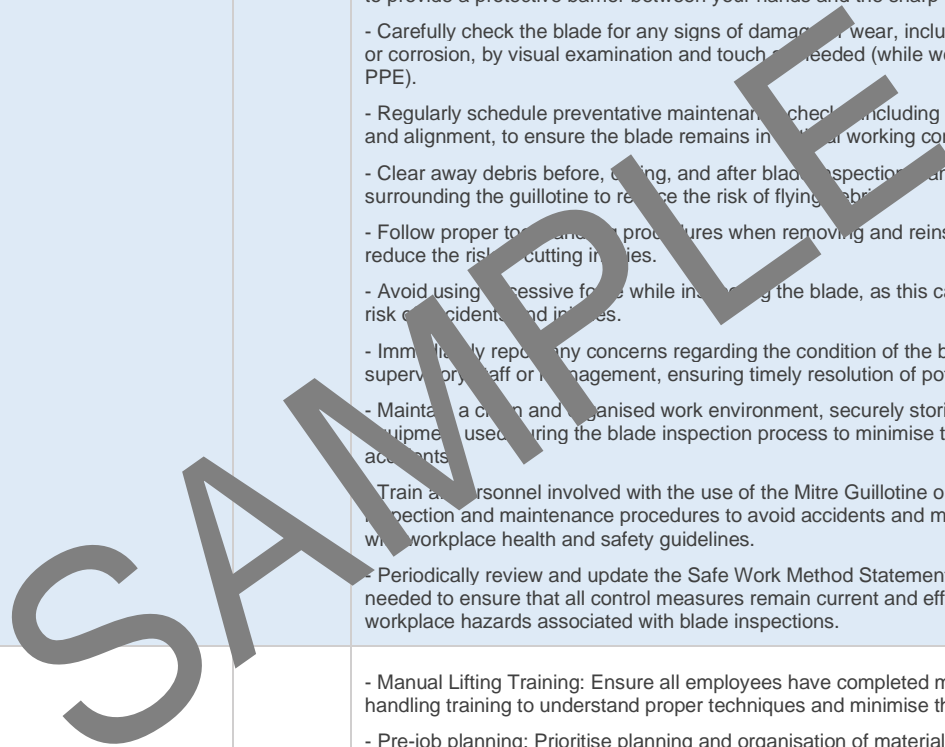
When a SWMS has been revised, the person conducting a business or undertaking must ensure all:

1. persons involved in the work are advised that a revision has been made and how they can access the revised SWMS;
2. persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS; and,
3. workers that will be involved in the work are provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

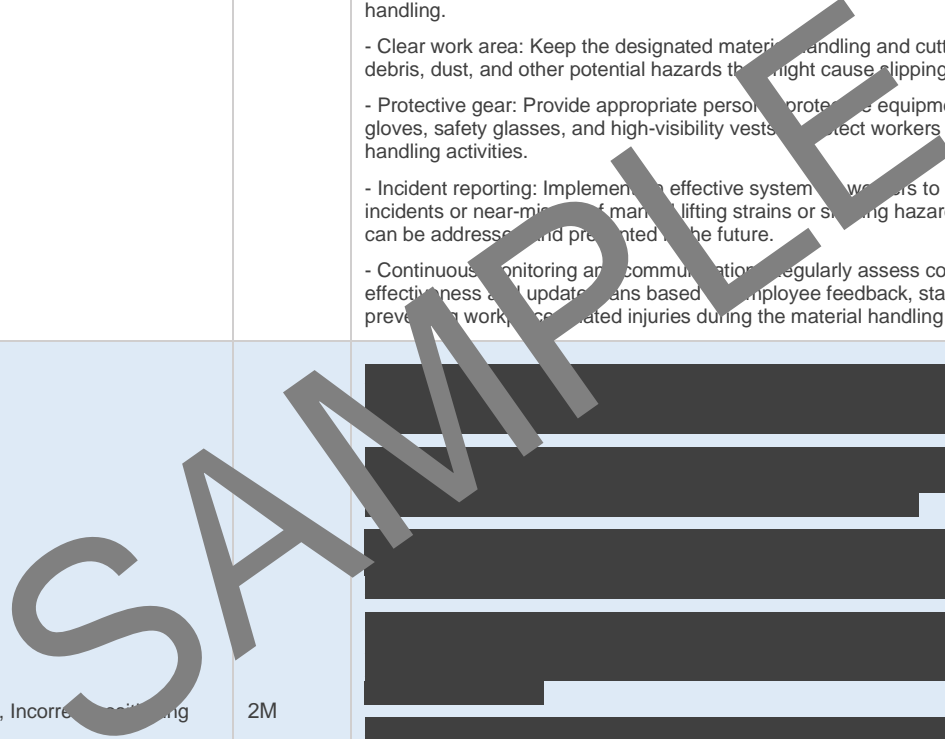

1. Preparation	Sharp edges, Tripping hazards	2M	<ul style="list-style-type: none"> - Inspect the work area for any potential tripping hazards such as cords, uneven or cluttered floor surfaces, and remove or mitigate them before starting the task. - Always wear proper personal protective equipment (PPE) that includes safety gloves to prevent injuries from sharp edges and safety shoes with non-slip soles to help prevent slips and falls. - Ensure that all workers are properly trained in the safe operation of the guillotine to minimise risks associated with its use. - Keep a clearly designated and well-maintained workspace around the guillotine to provide sufficient room for worker movement and reduce the risk of accidental contact with sharp edges. - Perform regular maintenance and inspections on the guillotine to ensure that it is in good working condition, free of defects or malfunctions that could pose additional risks during use. - Clearly mark and establish a 'no-go zone' around the guillotine to outline the boundaries within which workers should not be standing while the machine is in use, reducing the likelihood of accidents. - Implement a clear and systematic process for the removal and disposal of offcuts and waste materials to avoid buildup of debris, preventing both sharp edge hazards and trips. - Utilise tools such as trolleys, carts or other material handling equipment to safely move large and heavy materials in the workspace, reducing the need to lift and carry materials manually and lowering the risk of trips or falls. - Implement a buddy system where one worker operates the guillotine while another worker oversees the process, ensuring that safety procedures are followed and providing immediate assistance if needed. - Promote a culture of safety in the workplace by encouraging open communication among all workers about possible risks and the importance of following established protocols to protect everyone's well-being. 	1L	
2. Blade inspection	Cutting injuries, Flying debris	3H	<ul style="list-style-type: none"> - Always follow the manufacturer's guidelines while conducting blade inspections to prevent cutting injuries and minimise risks associated with flying debris. - Ensure that the machine is in complete STOP mode prior to beginning the inspection, and lock/tag out the equipment as necessary. - Wear appropriate Personal Protective Equipment (PPE), such as cut-resistant gloves and safety glasses, during the blade inspection process to reduce the risk of potential injuries. - Inspect the area surrounding the guillotine for any obstructions or loose materials that could pose a hazard during the blade inspection. 	2M

			<ul style="list-style-type: none"> - Use appropriate tools, such as a blade guard or blade block, during the inspection to provide a protective barrier between your hands and the sharp edge of the blade. - Carefully check the blade for any signs of damage or wear, including nicks, cracks, or corrosion, by visual examination and touch as needed (while wearing proper PPE). - Regularly schedule preventative maintenance checks, including blade sharpening and alignment, to ensure the blade remains in optimal working condition. - Clear away debris before, during, and after blade inspection, and clean the area surrounding the guillotine to reduce the risk of flying debris. - Follow proper tool handling procedures when removing and reinstalling the blade to reduce the risk of cutting injuries. - Avoid using excessive force while inspecting the blade, as this can increase the risk of accidents and injuries. - Immediately report any concerns regarding the condition of the blade to supervisory staff or management, ensuring timely resolution of potential hazards. - Maintain a clean and organised work environment, securely storing all tools and equipment used during the blade inspection process to minimise the risk of accidents. - Train all personnel involved with the use of the Mitre Guillotine on proper blade inspection and maintenance procedures to avoid accidents and maintain compliance with workplace health and safety guidelines. - Periodically review and update the Safe Work Method Statement (SWMS) as needed to ensure that all control measures remain current and effective in mitigating workplace hazards associated with blade inspections.

Material handling	Manual lifting strains, Slipping hazards	2M	<ul style="list-style-type: none"> - Manual Lifting Training: Ensure all employees have completed manual lifting and handling training to understand proper techniques and minimise the risk of strains. - Pre-job planning: Prioritise planning and organisation of materials on-site to reduce unnecessary manual lifting and transportation, decreasing potential risks. - Mechanical aids usage: Utilise mechanical aids such as trolleys, forklifts, or other equipment where possible to help with transporting heavy or large materials, reducing worker strain. - Proper footwear: Encourage workers to wear slip-resistant footwear with good ankle support to prevent slipping hazards and protect from potential injury due to dropped materials. - Safe storage: Store materials on shelves or in designated areas at a safe height to prevent the need for excessive bending or overhead reaching when lifting. - Teamwork encouragement: Encourage employees to work in pairs or groups for handling heavier or awkwardly-shaped materials, distributing the load and lessening individual strain. 	1L

			<ul style="list-style-type: none"> - Frequent rest breaks: Allow for regular short breaks throughout the workday to keep workers from overexertion and decrease the likelihood of injuries from manual handling. - Clear work area: Keep the designated material handling and cutting areas clear of debris, dust, and other potential hazards that might cause slipping or trip accidents. - Protective gear: Provide appropriate personal protective equipment (PPE) such as gloves, safety glasses, and high-visibility vests to protect workers during material handling activities. - Incident reporting: Implement an effective system to encourage workers to report any incidents or near-misses of manual lifting strains or slipping hazards, ensuring these can be addressed and prevented in the future. - Continuous monitoring and communication: Regularly assess control measures' effectiveness and update plans based on employee feedback, staying proactive in preventing workplace-related injuries during the material handling process.

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are needed. The review process should be carried out in consultation with workers (including contractors and subcontractors) who may be affected by the operation of the SWMS and their health and safety representatives who represented that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
