Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, to conduct and communicate those hazards and then to further take steps to either eliminate or control each hazard.			
If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.			
Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.			
The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

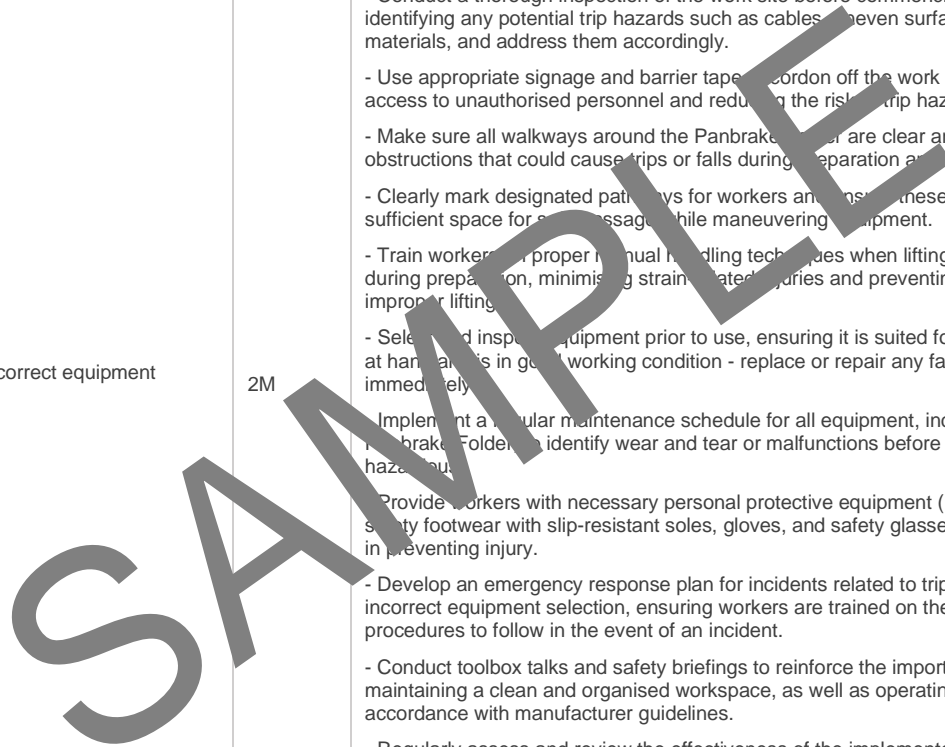

Note: A SWMS must be reviewed regularly to make sure it remains effective. A SWMS must be reviewed (and revised if necessary) if relevant control measures are revised. The review process should be carried out in consultation with workers (including contractors and subcontractors) who may be affected by the operation of the SWMS and their health and safety representatives who represented that work group at the workplace.

When a SWMS has been revised, the person conducting a business or undertaking must ensure all:

1. persons involved in the work are advised that a revision has been made and how they can access the revised SWMS;
2. persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS; and,
3. workers that will be involved in the work are provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

Preparation	Trip hazards, Incorrect equipment selection	2M	<ul style="list-style-type: none"> - Conduct a thorough inspection of the work site before commencing the task, identifying any potential trip hazards such as cables, uneven surfaces, or loose materials, and address them accordingly. - Use appropriate signage and barrier tape to cordon off the work area, minimising access to unauthorised personnel and reducing the risk of trip hazards. - Make sure all walkways around the Panbrake Folder are clear and free from obstructions that could cause trips or falls during preparation and operation. - Clearly mark designated pathways for workers and ensure these pathways provide sufficient space for safe passage while maneuvering equipment. - Train workers on proper manual handling techniques when lifting and moving items during preparation, minimising strain-related injuries and preventing falls caused by improper lifting. - Select and inspect equipment prior to use, ensuring it is suited for the specific task at hand and is in good working condition - replace or repair any faulty components immediately. - Implement a regular maintenance schedule for all equipment, including the Panbrake Folder, to identify wear and tear or malfunctions before they become hazardous. - Provide workers with necessary personal protective equipment (PPE) such as safety footwear with slip-resistant soles, gloves, and safety glasses or goggles to aid in preventing injury. - Develop an emergency response plan for incidents related to trip hazards and incorrect equipment selection, ensuring workers are trained on the proper procedures to follow in the event of an incident. - Conduct toolbox talks and safety briefings to reinforce the importance of maintaining a clean and organised workspace, as well as operating equipment in accordance with manufacturer guidelines. - Regularly assess and review the effectiveness of the implemented control measures and adjust or update procedures as necessary to maintain a safe work environment. 	2L

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are needed. The review process should be carried out in consultation with workers (including contractors and subcontractors) who may be affected by the operation of the SWMS and their health and safety representatives who represented that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
