Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, to conduct and communicate those hazards and then to further take steps to either eliminate or control each hazard.			
If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.			
Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.			
The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

When a SWMS has been revised, the person conducting a business or undertaking must ensure all:

1. persons involved in the work are advised that a revision has been made and how they can access the revised SWMS;
2. persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS; and,
3. workers that will be involved in the work are provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

Preparation	Fume inhalation, Slip and fall	2M	<ul style="list-style-type: none"> - Ensure proper ventilation in the working area to minimise fume build-up by incorporating exhaust fans, air vents, or open windows. - Utilise appropriate personal protective equipment (PPE) such as gloves, safety goggles, and a respiratory mask to prevent direct contact with harmful substances and fumes. - Clearly mark the designated working area with warning signs and hazard tape to alert workers and visitors of potential risks, including slips and falls. - Provide regular training sessions for employees on proper handling procedures when using parts washers and dealing with hazardous materials. - Implement and enforce standard operating procedures (SOP) for parts washing tasks, ensuring all employees are fully trained and compliant. - Conduct regular inspections of the working area to identify potential slip and fall hazards, particularly wet surfaces caused by spilled cleaning fluids, and promptly address these issues when identified. - Keep the working area clean and free from clutter to reduce the risk of tripping and slipping accidents. - Encourage the use of spill kits and absorbent materials to swiftly manage accidental spills when they occur and ensure prompt clean-up. - Install non-slip flooring or mats within the working area to enhance stability and ground, mitigating the risk of slip accidents. - Display clear Safety Data Sheets (SDS) in the working area that outline important information regarding the chemicals being used, including potential hazards, first aid procedures, and disposal guidelines. - Enforce mandatory break times to limit prolonged exposure to hazardous substances which could lead to fume inhalation risks. - Foster a culture of open communication where employees feel free to report any concerns, hazards, or near-miss incidents to management for review and action. - Continuously monitor and review work processes and protocols to identify opportunities for improvement in safety standards and hazard mitigation. 	1L

			<ul style="list-style-type: none"> - Conduct training sessions for workers who operate the parts washer, instructing them on safe operating procedures and the potential hazards they might encounter. - Ensure that workers wear appropriate personal protective equipment (PPE) while operating the equipment, such as gloves and safety glasses, to minimise the risk of injury from pinch points and electric shock. - Encourage workers to report any faulty equipment or hazardous situations immediately so that corrective action can be taken to mitigate the risk. - Maintain a clean and well-organised work area around the parts washer to reduce the chances of accidents involving pinch points or electric shock. - Install emergency stop buttons on the equipment to allow workers to quickly shut down the system in case of an accident or malfunction. - Perform routine checks on all equipment, cables, connections, and electrical panels to ensure they are in good working condition and do not pose any risk of electric shock. - Equip the parts washer with properly designed guarding mechanisms to protect workers from potential pinch points and other hazards associated with moving parts. - Establish and enforce lockout/tagout procedures when performing equipment maintenance or repairs to ensure workers are protected from accidental startups and potential injuries from pinch points and electric shock. - Educate workers on the importance of following safe work practices and adhering to workplace health and safety regulations to promote a culture of safety-consciousness within the organisation.

			<ul style="list-style-type: none"> - Spill response kits: Keep spill response kits readily available in the work area to facilitate quick action in the event of a spill or accident involving chemicals, reducing potential harm to workers and the environment. - Designated work areas: Establish designated areas for operating the parts washer, with clear signage and barriers to prevent unauthorised personnel from entering the space and coming into contact with contaminants. - Washing procedure: Develop a step-by-step washing procedure that outlines specific cleaning methods for different types of parts and materials, ensuring that contaminants are effectively removed while minimising potential hazards associated with the use of cleaning chemicals. - First Aid facilities: Make sure first aid facilities are available on-site to immediately provide care in case of chemical burns or other injuries sustained while operating the parts washers. - Regular audits: Conduct regular audits of the work environment and practices employed by operators to ensure full compliance with established health and safety regulations. Identify any areas for improvement and implementing necessary changes. - Safe Storage: Store chemicals and equipment used in the parts washing process in designated, secure storage areas, with proper signage indicating the presence of hazardous materials to minimise unintended exposure to harmful substances.

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are needed. The review process should be carried out in consultation with workers (including contractors and subcontractors) who may be affected by the operation of the SWMS and their health and safety representatives who represented that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
